- 3) Predict and protect against cyber-physical vulnerabilities in the timber industry; and
- 4) Facilitate the development of new case studies that provide a vision for new opportunities in the forestry industry in Alabama and the rural South.

Minimum Qualifications

Applicants must possess a PhD in forestry at time of employment. The individual must be self-motivated, have a solid background in forest operations, and be willing to conduct fieldwork and travel to remote research sites. A valid U.S. driver's license or the ability to obtain one is required. The successful candidate must meet eligibility requirements for work in the United States at the time the appointment is scheduled to begin and continue working legally for the term of employment.
